

SPLATMANDU PAINTBALL CLUB
"PLAY AT YOUR OWN RISK" CONTRACT

The sport of paintball involves action pursuit games in which opposing players attempt to shoot each other with dye-filled projectiles called "paintballs". Paintball is a serious sport, which makes rigorous demands on players' physical and mental abilities. When played in a safe manner, it can provide a rewarding experience not available in any other sport.

There are hazards in any active sport such as paintball. Serious injuries are rare, but do occur.

A 0.68 caliber paintball moving at high velocity adds a special dimension of hazard to paintball sports. At a minimum, it can cause pain and bruising. It can break the skin and cause bleeding. If it strikes an unprotected eye, ear or mouth it can cause blindness, deafness, or even death. If it strikes a young child in a sensitive body area, it can cause crippling or death. This is why proper safety gear for players, isolation of spectators from the play area and proper handling of paintball guns are absolutely essential.

The importance of ALWAYS following safety rules, and the risk of serious injury, require an adult level of maturity.

CODE OF CONDUCT
PLAY WITH HONOR

- 1) **I will NOT wipe paint.**
- 2) **I will follow the rules of the game and accept the referee's decision as final.**
- 3) **I will treat every paintgun as if it were loaded, and follow the rules of safe paintgun handling.**
- 4) **I will keep my goggles on while a game is in progress.**
- 5) **I will not deliberately make aggressive physical contact with another person;
I will be polite and respectful to others.**

I state that I am solely responsible for any and all liability, personal injury or property damage which may arise as a result of playing the sport of paintball and thereby assume all risk. In addition, I agree to indemnify and hold harmless Theodore N. Cross and Kathleen Cross, their representatives, affiliates, successors and assigns (hereinafter collectively referred to as SPLATMANDU) from and against any liability, damage, or claim, including, but not limited to, any legal costs, liabilities, and expense of any suit, claim, demand, or recovery.

I will hold SPLATMANDU harmless from any liability or causes of action that may likely arise as a result of any injury sustained while playing paintball at 13650 Harder Road, Three Rivers, Michigan 49093. In addition, I hereby authorize SPLATMANDU to utilize any and all photographs, pictures, video, or other likeness of me, as they deem appropriate in its promotional materials.
